- 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. The program has been granted accreditation for 3 years. Government Polytechnic, Jintur, Yeldari Road, Jintur, District-Parbhani, Maharashtra-431509 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
- 5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Government Polytechnic, Jintur, Yeldari Road, Jintur, District-Parbhani, Maharashtra-431509 as a whole.
